Previously Provisional Recognition has been accorded to the classes VI to X (EM&UM) in Moulana Abul Kalam Azad EM & UM High School, Jogannapalem, Dendulur Mandal, West Godavari District for the period from 2020-21 to 2022-23 Vide Proc.L.Dis.No.1313/A3/2020, Dated.03.01.2020 of the Regional Joint Director of School Education, Kakinada in the reference 7th read above.

The Correspondent of the School has submitted the proposal in respect of Moulana Abul Kalam Azad EM & UM High School, R.S.No.19/5A, B & 2C, Jogannapalem, Dendulur Mandal, Eluru District for Renewal of Recognition for the classes VI to X (EM&UM) for the years from 2023-24 to 2025-26 through the Deputy Educational Officer, Eluru in the reference 9th read above. The District Educational Officer, Eluru has verified the application for Renewal of Recognition with reference to the Inspection Report of the Inspecting Officer and as per the G.O.Ms.No.1 Education, Dated.01.01.1994.

As per the instructions of the Director of School Education, AP, Amaravati vide ref. 6th cited under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Kakinada, competent authority for Secondary Schools hereby grants **Renewal of Recognition** for a period of **03 (THREE)** years i.e., for the academic years from **2023-24 to 2025-26** for the classes **VI to X (EM&UM)** as recommended by the Deputy Educational Officer, Eluru and the District Educational Officer, Eluru subject to fulfillment of the following conditions in **Moulana Abul Kalam Azad EM & UM High School, R.S.No.19/5A, B & 2C, Jogannapalem, Dendulur Mandal, Eluru District**. That the society shall abide by the instructions / rules and regulations made by the Government or authorized Officer from the time to time.

1. That the Educational Institutions shall serve the needs of the locality more particularly.
2. The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
3. That the school timing vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
4. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern
5. That the results of institution shall be satisfactory every year.

6. That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
7. That the list of Governing Body shall be furnished to the District Educational Officer every year.
8. That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
9. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with.
10. That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before.
11. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
12. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.
13. That the society shall provide fire safety measures in the school as per the No Objection Certificate.
14. The management informed that no thatched roof accommodation is allowed to run the School.
15. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students
16. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
17. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments
18. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children
19. The school shall have first aid kit and the teachers shall be trained in first aid
20. The Correspondent of the concerned school is hereby informed to file an affidavit to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
21. That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail
22. That the management shall ensure the Accountants of this school audited by an authorized Chartered Accountant every year and submit.
23. That the management has to maintain trained teachers at all time
24. The management is informed to follow the guidelines issued in G.O.Ms.No.91 School Education PS, Dated. regarding Fee Structure in Private Schools.
25. That the Management of the school is informed that, these orders are issued subject to conditions that, to obtain and submit the occupancy Clearance of fire issued by the concerned department within the stipulated dates mentioned in the order and submit to this office through the inspecting officer concerned for the entire period of recognition without fail. If the management fails to comply with the above conditions promptly, the Recognition now granted will be reviewed
