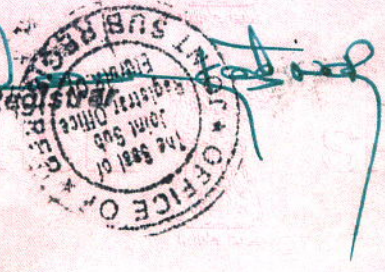

4.(3) The Managing Trustee shall act as the Secretary of the Advisory Board and shall call for meeting of the Board once a year or any time as may be deemed necessary giving at least 15 days time. The Quorum shall be not less than 3 members.

THE OBJECTS OF TRUST

- 5.(1) To establish, aid and maintain educational and other institutions, impart education at all stages for the promotion of literature arts and science and all other subjects for diffusion of useful knowledge temporal or spiritual.
- 5.(2) To establish and conduct hospitals dispensaries or medical clinics.
- 5.(3) To establish and conduct schools, colleges or other institutions for imparting any type of education.
- 5.(4) To establish conduct libraries, home for destitutes, women and children.
- 5.(5) To equip all such institutions, hospitals, schools colleges and homes with all necessary paraphernalia, sophisticated gadgets and instruments and all other things required.
- 5.(6) To render financial help to any educational medical or charitable organisation or organisations which is the opinion of the trustees is or are in need of help.
- 5.(7) To provide for payment of scholarships to needy students.

5.(8) To encourage deserving and meritorious students by awarding suitable prizes either instituted in educational institution or any other means.

5.(9) To open orphanage homes or assist in the conduct of any institution or institutions for protection of orphans.

5.(10) To give monetary aid or otherwise provide for relief of victims affected by flood, famine, fire, and other natural calamities like earthquakes, cyclone, etc.

5.(11) To provide for construction of buildings for the accommodation and conduct of schools, colleges, libraries, research institutions, medical clinics, Prayer houses etc.

5.(12) To provide for the feeding of poor and disabled persons or for maintenance of homes or institutions for the poor and disabled persons and old people.

POWERS OF TRUSTEE

6. In order to carry out the objects of the trust as mentioned above the trustees shall have the following powers:-

a) To purchase, or take on lease for any period of time or otherwise acquire and immovable property consisting of land and building etc.,

b) To accept gifts or any voluntary contributions from any persons install charity boxes and or otherwise collect subscriptions or donations to augment the Trust Fund and use such monies for the objects of the Trust. It shall always be open to the trustees in their absolute discretions to accept or refuse any such donations, gifts and contributions.

c) to raise or borrow moneys required for the purpose of any of the objectives of the Trusts and for buying taking on lease or otherwise any movable or immovable properties in such terms and conditions as the Trustees may be their absolute discretion think fit and proper.

d) to employ or engage, managers, supervisors, clerks, teachers and all other types of employees and to fix their terms of employment in general or in particular to any individual and to pay their remuneration or salaries or wages as may be fixed from time to time.

- e) to establish an office/offices of the trust in any part of India as they may think fit and proper from time to time.
- f) To draw, make accept, endorse discount execute and issue bills of exchange, promissory notes and other negotiable or transferable instruments or securities.
- g) to open bank account or accounts of the trust in the name of the trust in any schedule banks or nationalised banks as may be decided by them from time to time and close such account or accounts and to open new accounts in any such bank/banks to operate on any bank account/accounts by the said trustees.
- j) To appoint Architects, Chartered Accountants, doctors, Bankers and Lawyers or any other persons to transacts any business or to do any act required to be transacted or done in the execution of the Trusts hereof including the receipt and payment of money and to pay their fee and all charges and expenses incurred but the trustees shall not be responsible for the default of any such agent, employed in good faith.
- k) The trustees shall have power to lease the trust premises or any part thereof for any purpose and for any term whatsoever and may accept and surrender of any such lease and in particular to administer the properties without let or hindrance.
- l) The Trustees shall have full powers to file and defend any suit, appeals applications etc. and any one or more of them being duly authorised and shall have power to declare sign and verify all plaints, written statements, affidavits, criminal complaints etc. and to appear before any court of law, Tribunals, Tax authorities, and before any Registrar or sub Registrar of Assurances at any place in India and to present and lodge any document for registration and to admit execution thereof and to compound all actions, suits, complaints, and other proceedings and all differences, disputes or demands to arbitration and adjust, approve and settle all accounts relating to the Trust property and to execute all releases and discharges and to do all other things relating thereto.
- m) The Trustees appoint Md.Wasiullah as the Managing Trustee of the Trust. The Trustees shall hold Office for their life. Any vacancy by means of resignation or death, shall be filled by surviving trustees.

o) The Managing Trustee is empowered to carry on the day to day affairs of the Trust in consultation if necessary with the assistance of the other trustees and shall also follow the guidelines laid down by the advisory Board and shall be paid a Honorarium, as decided by the advisory Board.

7.(1) The Trustees shall keep proper books of accounts of the income and expenditure of the Trust, which shall be closed every year and the statement of the accounts of Moulana Abul Kalam Azad Charitable Educational Trust be drawn up at the end of the official year ending on 31st March.

7.(2) In case of dissolution the funds and properties of the trust shall be transferred to any other Trust/Institution having similar objects only, to which provisions of section 12, 12(A) and 80 (G) of Income tax act 1961 shall apply.

7.(3) The Trustees are not entitle to change any of the objects or clauses of this trust deed without the express permission of the commissioner of Income tax having Jurisdiction over the Principle place of the Trust.

7.(4) The Trust does not own any immovable property as on today.

7.(5) The Trustees shall at all times stand indemnified in respect of any act that may have been done bonafide by then in respect of matters relating to the Trust.



4. As per the resolution passed by the Trust Board, it is deemed that if any student behavior his/ her parent / guardian is repeatedly found misbehavior and in disciplined despite counseling, the Management has the prerogative to cancel his / her admission.
5. All the trustees unanimously resolved to depute to look after the activities of MAKACET regularly by appointing Mohammad Wasiullah as Secretary / Correspondent of the institution.
6. The Address noted in the Trust Deed changed as follows :

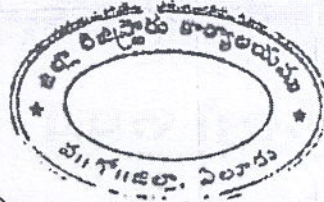

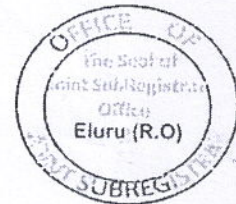
